State Park Update – State Park Representatives reported that they are currently celebrating Christmas in July. The campground has been full every weekend and is doing well as is the shelter houses. Steve Terrill moved to adjourn the meeting. Kay Daugherty seconded. Motion passed unanimously.

Dr. Jennifer Jones, Restorative Lake Sciences Update – Dr. Jones updated all in attendance regarding the current status of the weed removal project currently being done at the lake. There is still a long way to go and they are being very selective what is being done. The dissolved oxygen level remains good. They are being very conservative with chemical usage. The overall goal is to remove milfoil and have native plants to replace it. The biggest concern is the runoff entering the lake from the tributaries e creating harmful algal blooms. It is very import to focus on the usage of filters to help eliminate the infiltration of from the tributaries. Clarity without milfoil is the overall goal. The zebra mussels are on a downward cycle of their lifecycle but will be back in 2-3 years. The harvesters are focusing on the removal of the contrail. We are a victim of mother nature which is affecting the water temperatures of the lake.

The next regularly scheduled ILWP Board of Directors meeting will be held 6:00 P.M., Wednesday, August 16, 2023 at the Indian Lake State Park Multi-Purpose Building.
