State Park Dredge Material

Need fill or topsoil? The Ohio Department of Natural Resources, Division of Parks and Watercraft is making dredge material available to interested contractors, builders, and residents in the Indian Lake State Park region.

Dredge material is pumped from shallow areas of the lake bottom. Once removed from the lake, the material is stored and dried out at a dredge material relocation area (DMRA).

Dredging at Indian Lake is restricted to areas within 1 mile of a DMRA. Once a DMRA is full, it cannot be reused until the original stored material is removed. Dredge material can be made of several types of soil, such as clay, sand, gravel, and silt.

There are several DMRAs, around Indian Lake including sites at Moundwood, Old Field beach, the state park maintenance facility, and Chippewa Marina. These sites are all accessible by car or truck.

The public must use their own tools and equipment, such as shovels, loaders, or back hoes, to remove the dredge material. Private vehicles must be used to transport the dredge material. All participants must also sign a waiver of liability.

Contact Dan Gillis, West Central dredge supervisor with ODNR Division of Ohio State Parks and Watercraft, before removing dredge materials. You may reach him by email at dan.gillis@dnr.ohio.gov or by phone at (614) 634-0747. Gillis can answer questions related to types of material best suited to your needs.

Currently, ODNR is constructing a new DMRA on the northeast side of the lake but continues to seek additional upland sites on private lands close to Indian Lake. Additional sites will ensure the continued dredging

of the lake. If you have vacant land or know of suitable land for this use, contact Gillis.

Lake Raker

Due to the amazing water clarity and quality, 2020 was a great year for aquatic plants! These aquatic plants become a weed problem when they grow in the way of boat traffic, fishing spots, and swimming areas. This is where the "Lake Raker" weed harvester comes in!

The ILWP, with generous donations,

purchased the Lake Raker in 2010. Through an agreement between the ILWP and Indian Lake State Park, the State Park runs the weed harvester. The weeds can only be harvested when they reach full maturity, which is sometime around June and July. Depending on the wind direction and weather, the Lake Raker will make its way clockwise around the lake from Old Field Beach, clearing channels and hitting hot spots.

After they complete this pass, the harvesting is opened up to reported troubled locations. If you know of a channel or area that needs the Lake Raker, call or email the State Park and give your name, address and phone number. This is the best way to pinpoint the problem locations and a way to contact you for more information.



WATER QUALITY NEWS

2020 Water Quality Report

The microcystin monitoring was a highlight of 2020. Five out of seven samples, that were lab tested, came back too low to measure! This is amazing! The blue green algae toxin was almost nonexistent in Indian Lake in 2020. One sample result of 0.413 ppb, was most likely taken after a rain event. This would increase the amount of available nutrients for algae to feed on in the lake for a short time. Thus the spike in microcystin.

A exact reason for these results would be hard to point to. It is more likely that a combination of many years of conservation practices and the lack of boat traffic early in the season due to covid. Whatever the reason we love the results!

In addition to the microcystin testing, the ILWP began a Tributary Monitoring Program. Water samples were taken from the mouth of the North and South Forks of the Miami River, Van Horn Creek, Black Hawk Run and downstream of the spillway in the Miami River. This will set a baseline for future testing. All the tested results are within normal levels.

The ILWP plans on continuing all monitoring projects into 2021.

There are four measurement levels for microcystin in parts per billion (ppb).

- 0.3-1.6 ppb Drinking water advisory for infants and people with compromised immune systems
- 1.6-6.0 ppb Drinking water advisory for adults
- 6.0-20.0 ppb Public Health advisory
